Investment Objective

The fund seeks total return.

The fund is designed to achieve positive total return relative to the performance of the Bloomberg Commodity Index Total Return (BCOM Index).

Investment Approach

Invests in commodity-linked derivative instruments, backed by a portfolio of short-maturity investment-grade fixed income securities normally having an average duration of one year or less. Invests in futures contracts on individual commodities or a subset of commodities, structured notes and/or swaps and options on them through investments in a wholly-owned subsidiary of the fund formed in the Cayman Islands. Cash collateral is managed conservatively, using a risk-controlled process that seeks to maintain the diversification qualities of the benchmark.

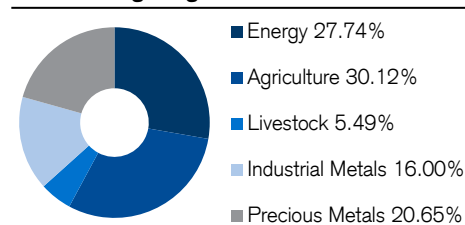
Quarterly Performance Summary:

- Class I of the Fund declined -5.53% at NAV during the first quarter compared to the Bloomberg Commodity Index which declined -5.36%.
- Commodity exposure was generally positioned further out along the curve during the quarter.
- Curve positioning in the Agriculture and Livestock sectors detracted from benchmark-relative performance while positioning within the Energy, Industrial Metals and Precious Metals sectors contributed to returns, gross of fees.
- Fixed income collateral management added to relative performance.

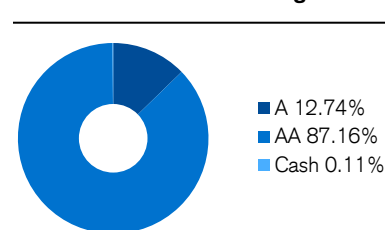

**The fund itself has not been rated by an independent rating agency. Credit quality ratings on underlying securities of the fund are received from S&P, Moody's and Fitch and converted to the equivalent S&P major rating category. This breakdown is provided by Credit Suisse and takes the median rating of the three agencies when all three agencies rate a security the lower of the two ratings if only two agencies rate a security and one rating if that is all that is provided. Unrated securities do not necessarily indicate low quality. Below investment-grade is represented by a rating of BB and below. Ratings and portfolio credit quality may change over time.

The Trust is authorized to reimburse Credit Suisse for management fees previously limited and/or for expenses previously paid by Credit Suisse, provided, however, that any reimbursements must be paid at a date not more than three years after the end of the fiscal year during which such fees were limited or expenses were paid by Credit Suisse and the reimbursements do not cause a class to exceed the applicable expense limitation in the contract at the time the fees were limited or expenses were paid. This contract may not be terminated before February 28, 2024.

The beta shown is correlated to the Bloomberg Commodity Index Total Return. The measurements shown are for the trailing three years for Class I shares. Other share classes may differ. ⁵ The current maximum initial sales charge for Class A shares is 4.75%. The initial sales charge is reduced for larger purchases. Purchases over \$1,000,000 or more are not subject to an initial sales charge but may be subject to a 0.50% CDSC on redemptions made within 12 months of purchase. The current maximum CDSC for Class C shares is 1.00% during the first year. ⁶ The Bloomberg Commodity Index Total Return is composed of futures contracts on 24 physical commodities.
